Subject: Change and new terms relating to the public selection of one – level two technologist – category D3 for a period of 36 months, which may be extended, at the Department of Biology and Biotechnology at the University of Pavia providing support for research and administrative activities for the: Ecosistemi Innovazione "Nodes" SPOKE6: PRIMARY AGROINDUSTRY project – part of the PNRR

THE DIRECTOR GENERAL

Considering the resolution no. 912/2022, prot. no. 176733 of 08/11/2022, relating to the Public selection of one – level two technologist – category D3 for a period of 36 months, which may be extended, at the Department of Biology and Biotechnology at the University of Pavia providing support for research and administrative activities for the: Ecosistemi Innovazione "Nodes" SPOKE6: PRIMARY AGROINDUSTRY project – part of the PNRR and in particular article 2, relating to the gualification required for admission to the selection;

Considering that among the qualifications required for admission to the selection, the degree L-27 (Chemical sciences and technologies) was indicated, by mere typo error, instead of L-13 (Biological sciences) according to the regulations governed by the Ministerial Decree 270/2004;

Considered the need to include among the evaluable qualifications already indicated the master's degrees in class LM-9 Biotechnology, according to the system regulated by Ministerial Decree 270/2004, and in class LS9-Biotechnology according to the system regulated by Ministerial Decree 509/1999 and degree in Biotechnology old system (prior to Ministerial Decree 509/1999);

Considering that the deadlines for submitting applications to participate in the selection will expire on 12/12/2022;

Waiting therefore, the need for new deadlines for the selection procedure for above position;

Deemed it necessary to proceed

PROVIDES

Art. 1 – The first paragraph of article 2 of resolution no. 912/2022, prot. no. 176733 of 08/11/2022, relating to the Public selection of one – level two technologist – category D3 for a period of 36 months, which may be extended, at the Department of Biology and Biotechnology at the University of Pavia providing support for research and administrative activities for the: Ecosistemi Innovazione "Nodes" SPOKE6: PRIMARY AGROINDUSTRY project – part of the PNRR - and in particular article 2, relating to the qualification required for admission to the selection; –, published in the Official University Register from 10/11/2022 to 12/12/2022, must be understood as replaced as follows:

For admission to selection, candidates must possess the following requisites, which must be held at the deadline date for the presentation of the admission application and when they take up service:







Qualification: a university degree required in class L-2 Biotechnology or **L-13 Biological Sciences** under the regulations laid down by Ministerial Decree 270/2004 or in class L01 Biotechnology or L12 Biological Sciences following the regulations laid down by Ministerial Decree 509/1999 or a degree in Biology under the old regulations (before Ministerial Decree 509/1999) or another equivalent qualification following the rules in force.

- **Art. 2** The first bullet point of article 6 of the call must be considered integrated with the master's degrees in class LM-9 Biotechnology, according to the system regulated by Ministerial Decree 270/2004, and in class LS9-Biotechnology according to the system regulated by Ministerial Decree 509/1999 and degree in Biotechnology old system (prior to Ministerial Decree 509/1999).
- **Art. 3** For the reasons indicated in the introduction and in articles 1 and 2 of this provision, the deadlines for applications will expire 30 days from the date of publication of the managerial resolution in the Official University Register.

All the other provisions of the aforementioned resolution no. 912/2022, prot. no. 176733 of 08/11/2022, and any applications already submitted for participation are also valid.
