INSURANCE COVER FOR UNIVERSITY OF PAVIA STUDENTS
DURING ERASMUS MOBILITIES

Every student registered at the University of Pavia benefits from the following insurance policies:

- **INAIL** – cover for accidents in the work place and other other injuries/professional illnesses;
- **Insurance policy for third party liability** n. 1911090 Lloyd's;
- **Supplementary Accident Insurance** n.802534120 Amissima Assicurazioni.

Recent graduates participating in the program benefit from:

- **INAIL** – cover for accidents in the work place and other other injuries/professional illnesses;
- **Insurance policy for third party liability** n. 1911090 Lloyd's;
- **Supplementary Accident Insurance** n.802534120 Amissima Assicurazioni only subscribing to it at the cost of €3,69 (annual fee). Instructions on how to subscribe are available on the website.

INSURANCE POLICIES are valid all over the world.

Insurance policy for third party liability: this excludes all damages caused by professional negligence and medical malpractice.

Accident Insurance: the accident occurred while commuting to and from the university/workplace (*in itinere*) is not insured.

You are reminded that the insurance provided by the University of Pavia only covers the student for risks connected to direct and authorised teaching, studying or research activities connected with their mobility period.

INAIL

This cover **only** concerns activities involving laboratory work, general tools, physical, chemical or biological agents, including work with computers – limited to periods when the student is actually involved in using the mentioned instruments and laboratories.

In the case of an accident on the premises of the host enterprise in one of the instances described above, the student must:

1. go to the Emergency Department of a local hospital
2. send immediately to the Servizio Relazioni Internazionali – Mobilità Internazionale, by fax (+39 0382 984314) or by e-mail (erasmus@unipv.it or train.erasmus@unipv.it):
 - a medical certificate signed by the first aider outlining the prognosis
 - a brief description of the accident
 - a translation (also done by the student) in case of a certificate in a foreign language.

The Office will send the documents to the competent university offices that will eventually forward the claim to INAIL if appropriate (in cases of a prognosis of more than 3 days).

THIS DOCUMENT CONTAINS NO REQUIREMENTS FOR PRIVATE HEALTH INSURANCE POLICIES (those not required by law).

Therefore, before leaving for a foreign country:

- **in the EU**, you are advised to check the validity of the student's EHC card with the appropriate ASL and, if requested by the host country, make provision for a TEAM card (you have to request one in person, consult the website www.asl.pavia.it)
- **for destinations other than EU**, it is strongly advised that you consult the website of the Italian Ministry of Health (www.salute.gov.it) or, again, the competent ASL.

If you are a Non-EU citizen, you should provide for your own private health insurance before leaving your home country or, as a temporary resident in Pavia, enrol with the National Health Service at the Azienda Sanitaria Locale - ASL (Local Health Unit) at www.asl.pavia.it/.
