### ART. 1 - TYPOLOGY

The University of Pavia announces for academic year 2016/2017, a two-year, First level Masters course (in English) in Musicology: "Music and Cultural Practice in Europe" at the Department of Musicology and Cultural Heritage.

### ART. 2 - EDUCATIONAL GOALS AND PROFESSIONAL OPPORTUNITIES

The proposal to announce a First level International Masters course derives from two principal motivations: firstly, the observation that professional opportunities in intellectual fields should be undertaken on an international field; secondly, the need to tap into the flood of students from various parts of the globe who are looking for a centre of educational excellence.

The University of Pavia's Department of Musicology and Cultural Heritage boasts features that are unique on a national and international stage. In all, 17 professors are attached to the department, operating under SDS L-ART/07 and L-ART/08. They are able to cover practically every competence in the two musicology sectors, distributed uniformly in a chronological arc from ancient Greek to contemporary.

The Department of Musicology and Cultural Heritage was established in 2012 following the fusion of the Faculty of Musicology and the Department of Musicological and Paleographic-Philological Sciences. This was in application of Law No.240, dated 30 December 2010, and subsequent modifications by the University of Pavia. The Department's teaching and research activities are distinguished by a clear vocation to establish international relations; this emerges from the curricula of individual professors and the activities organised by the department. These include inter-institutional projects and a full programme of seminars and conferences held by visiting professors from overseas institutions.

The main objective of the Masters course is to provide a basic methodology, technical skills and the cultural grounding necessary to carry out musicology research at the highest level and, more in general, in depth discourse in the field of music. According to current musical standards, musical knowledge is a complex entity and articulated on various levels; it concerns musical texts and theories, compositions and performances, popular music and music as an art form, the diffusion of music in the media and its collocations in social contexts. The proposed Masters course guides students towards this interdisciplinary and composite knowledge, one that is fundamental for admission to international doctorate courses, accessing management level positions at institutions conserving and promoting musical sources, to the transmission of musical culture and the creation, planning and realisation of cultural events with musical content.

Graduates of the course may find opportunities in:

- international doctoral positions
- accessing management level positions at institutions conserving and promoting musical sources
- the transmission of musical culture
- the creation, planning and realisation of cultural events with musical content

#### ART. 3 - DEGREE COURSE PROGRAMME

The duration of the Masters course is **two years** and has a timetable of **3000** hours, including frontal lessons, workshops and seminars at the Department of Musicology and Cultural Heritage, placements at public and private organisations with which agreements are about to be finalised, and, to conclude, studio activities and individual preparation.

In total, the course activities correspond to 120 CFUs (university credits).

Each credit is the equivalent of 25 hours of activity, thus divided:

modules I, II, III:

5 hours of frontal lessons 20 hours of individual study

module IV: 5 hours of practical exercises 20 hours of individual study

Up to 25 placement hours (including guided distance learning).

Students **must** attend at least 75% of the overall course activity hours.

The course cannot be suspended.

Transfers from other Masters courses at other universities are not permitted.

Placements will take place at the Editrice Ricordi di Milano publishing company, il Festival Milano Musica, l'Istituto per la Musica della Fondazione Giorgio Cini (Venice), il Teatro alla Scala, il Centro Studi Giacomo Puccini.

Depending on the number of enrolments, agreements with other organisations will be activated, including II teatro Ponchielli (Cremona), il teatro Donizetti (Bergamo), il teatro Regio (Parma), il teatro Regio (Turin) and the il Festival Monteverdi (Cremona).

Placement activities will be defined, on a case-by-case basis, by the contacts from the two institutions and will include an internship at the host organisation and periods of coursework assigned by the Masters institute.

# ART. 4 – LEARNING ASSESSMENTS

Learning will assessed during the course. Professors will evaluate achievements through written and oral tests at the end of each module.

# ART. 5 - OBTAINING THE QUALIFICATION

At the end of the Masters course, students who have completed all the activities and met all the programmed obligations will be awarded a two-year, first level Masters Diploma in Musicology - "Music and Cultural Practice in Europe" - subject to the passing of a final examination consisting in an original piece of written work to be evaluated by the Teaching Board.

The maximum number of enrolments is 25.

The minimum number of enrolments to activate the course is 15.

The Teaching Board may evaluate whether the conditions exist to broaden intake.

When pre-enrolling, candidates should send a curriculum vitae (CV) and motivational letter (in English) to be evaluated by the Teaching Board. A positive evaluation will lead to the candidate being admitted to the Masters course.

If the number of candidates who <u>meet the admission requirements, and have a CV and motivational letter positively evaluated,</u> exceeds the maximum number foreseen, a ranking list will be drawn up by a commission composed of a Co-ordinator and two Masters professors. Scores will be awarded to a maximum of **60**, based on the following criteria:

- Up to a maximum of 25 points for an interview (that may be held face-to-face or online via Skype) designed to evaluate candidates' knowledge of the fundamentals of musicology. This will include the principles of musical theory and knowledge of musical repertoire. The pass mark for the interview is 15 points.
- 2. **Up to a maximum of 20 points**: 5 points for each additional university degree from those specified in article 7 and equivalent qualification and for each additional higher education musical diploma and equivalent qualification.
- 3. **Up to a maximum of 15 points** for candidates' knowledge of English to be assessed during the interview described in point 1, which may be held face-to-face or online via Skype.

In instances where candidates have the same score, the younger candidate will prevail.

In cases in which one or more candidates withdraw, the available places will be offered, in order of merit, to candidates who appear on the ranking list.

#### ART. 8 - APPLICATIONS AND DEADLINES

Candidates must send the admission form, adhering to the methods established in the call for applications, from 22 March 2016 to 30 June 2016.

## ART. 9 - ATTACHMENTS TO THE ADMISSION FORM

Candidates should attach to the Masters admission form the following documentation:

1. A self-certification of qualifications to be evaluated (article 7, point 2)

Candidates who hold qualifications awarded overseas should attach the documentation requested in article 3 of the call for applications;

- 2. A curriculum vitae (CV) in European format;
- 3. A motivational letter

The CV and motivational letter should both be written in English.

# ART. 10 - FEES AND CONTRIBUTIONS

#### **Enrolment:**

Candidates enrolling for the Masters course should, for the 2016/2017 academic year, pay the sum of €3,500.00 (€7,000.00 for the two years) that is inclusive of the €16,00 revenue stamp, €3,69 personal injury insurance, €134,00 "Expenses for student services" and €2,00 "Co-operation and knowledge fund".

For the 2016/2017 academic year, the sum of €3,500.00 must be paid in a single instalment upon enrolment.

#### Final test:

To be admitted to the final test, candidates must present a dedicated admission form bearing a €16.00 revenue stamp and pay the sum of  $€97.00^{1}$  (of which €16.00 is a revenue stamp paid virtually on the parchment) for the issue of the parchment.

National or overseas organisations or individuals may contribute to the running of the Masters course through financing, partially or in full, the registration fee.

In such instances, candidates will be selected based on criteria established by the Teaching Board and published on the website of the administration office organising the Masters course.
